The City of Harbor Beach is requesting sealed bids from contractors and suppliers for various projects, material, components and proposals for various projects for the Harbor Beach Marina Renovation. Bids will be awarded for each separate scope item.

### **Contractors will be sought to submit bids for the following scope items:**

- Plumbing shower room / restroom
- Fire suppression piping marina docks
- Electrical upgrade shower room / restroom / office building
- Electrical upgrade marina docks
- Partition replacement shower room / restroom
- Door replacement (6) shower room / restroom / office building
- Sheet piling
- Concrete flatwork – sidewalks, ramps, and aprons
- Asphalt - drive and parking area
- Painting the inside of the restrooms, shower rooms, office building

### **Contractors will be sought to submit proposals for the following scope items:**

- Grind and resurface floors in the restrooms, shower rooms & office
- Fuel system upgrade

### **Supplies will be sought to submit bids for material and components:**

- Electrical components and supplies
- Aggregate
- Steel
- Aluminum

**The City of Harbor Beach will treat all bids, proposals and components submissions separately.** All bids, proposals and components submissions must be presented individually in a sealed envelope.

All contractors must comply with all requirements of 1976 PA 453 (Elliott-Larsen Civil Rights Act) and 1976 PA 220 (Persons with Disabilities Civil Rights Act), as amended. All contracts must contain a covenant by the contractor, subcontractor, or supplier not to discriminate against an employee or applicant for employment with respect to hire, tenure, terms, conditions, or privileges of employment, because of race, color, religion, national origin, age, sex, height, weight, marital status or a disability that is unrelated to the individual's ability to perform the duties of a particular job or position.

Bids, proposals and components submissions must be delivered in a sealed envelope, properly marked to identify content. Each category must be bid separately in a separate envelope. Faxed and e-mailed proposals will not be accepted.**
