Businesses Article II Transient Merchants* Sec. 8-31.

Transient Merchant means any person, firm, association or corporation engaging temporarily in a retail sale of goods, wares or merchandise, in any place in the City and who, for the purpose of conducting such business, occupies any lot, building, room or structure of any kind, or goes about from place to place in the City for the purposes of selling or peddling goods, wares, merchandise or refreshments of any kind either by foot or by any mode of conveyance, whether it be on streets, highways, alleys, sidewalks or in or upon wharves, docks or from boats, open places or spaces, public grounds or places in the City.

By signing this application, the applicant agrees to accept these conditions if the license is issued.

- A. The applicant/business agrees to pay the license fee: \$500 per year, \$100 per month, \$50.00 per week, \$20.00 per day.
- B. The applicant/business will provide a copy of a valid Security Bond in the minimum amount of \$10,000 US Currency.
- C. All Transient Merchants shall abide by Local Ordinances, State Laws, and Federal Laws.
- D. No Transient Merchant or their customers shall obstruct any street, alley, sidewalk or driveway.

- E. No Transient Merchant shall remain in front of or at the side of any property against the wish or desire of the property owner or the tenant or occupant of such property.
- F. No Transient Merchant shall threaten or accost any resident of the City in the course of any solicitation, peddling or other sales activity nor engage in any conduct which is a nuisance or would tend to create a nuisance.
- G. No Transient Merchant shall enter a dwelling or place of business under false pretenses, for the purpose of peddling or soliciting, nor remain in a dwelling or on the premises of a place of business after the owner or occupants has requested the Transient Merchant to leave.
- H. No Transient Merchant shall sell or offer for sale any unsound, unripe, or unwholesome food or drink, or defective, default, incomplete or deteriorated article of merchandise.
- I. The Harbor Beach Police Department may immediately revoke or suspend this permit due to any violation of these conditions, a Local Ordinance, or a State or Federal Law.

7. EXEMPTIONS:

- A. Any person under eighteen {18} years of age, when engaged in peddling in the neighborhood of his or her residence under the direct supervision of any school or recognized charitable or religious organization.
- B. Any person or firm during special celebrations or festivals approved by the City Council.
